On the Search Page, select the Case Option that you want to search by (Civil or Criminal). Enter one or more search fields and Click on Captcha. Click on the Submit button to view the results. Only the first 5000 records will be retrieved. Narrow your search as much as possible by entering information into more than one search field.

- Search by Name/Dates.
 - Select Civil Cases or Criminal cases depending on the type of cases you want to search.
 - Select the specific case type from the drop down or select All to get all case types.
 - Phonetic search is available only for Last Name and First Name.
 - You may enter a case file date range for your search using the Beginning Case Filing Date field and the Ending Case Filing Date field. For more results leave blank.

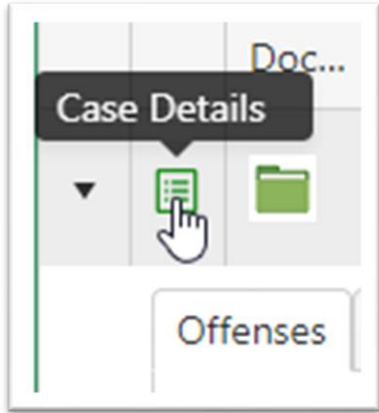
